

## Another excellent year for Swedish pensions and savings platform Futur

*Excellent, resilient performance of Futur Pension in 2022: profits up 40%, #1 premium market share*

Despite the backdrop of a very difficult macroeconomic environment, Futur Pension ("Futur") has closed the year with very strong results. The pension and savings platform has continued to outperform the market and demonstrated the resilience of its high-growth and low-risk business model:

- Net income increased by 42% from SEK 182m (2021) to SEK 260m in 2022.
- Premium volume has kept up well at SEK 36.5bn, its second-best year ever despite the challenging market environment.
- With a market share of more than 11% of premiums, Futur has become the Swedish

market leader in H1 2022 for the first time ever, marking another milestone for the company's continued excellent performance.

- The strong premium volume resulted in a net money inflow of SEK 15 bn. AuM stood at SEK 169bn at year-end, as the negative market effect could not be fully compensated by net money inflow from customers.

Overall, Futur is on an excellent track to continue its growth journey, growing its AuM and premiums by more than 20% p.a. since 2010, more than twice as fast as the Swedish life insurance industry.

Its proprietary, state-of-the-art IT platform and focus on distribution through more than 40 partners builds the base for strong competitive advantages:

- High satisfaction levels (NPS 42 in 2022) of distribution partners
- Unrivaled cost ratio of 0,07% of AuM and 0,3% of premiums, which is more than 10 times better than the European industry average
- Short time-to-market

These competitive advantages, combined with high operating leverage, pave the way for the continued success of Futur.
